

#### **RETAIL THEFT TRAINING SEMINAR**

The District Policing
Partnership (DPP), Ballymena
Retailers against Crime
(BRAC), Ballymena Borough
Chamber of Commerce and
Industry and the PSNI recently
held a training seminar in
Montgomerys. The seminar
focused on retail theft
observation skills, deterrent
methods and detention of
culprits. Approximately 70
people were in attendance.

Audrey Wales (DPP) welcomed everyone to the meeting saying that it was great to see so many present and that she hoped they would all find the seminar to be beneficial. The seminar was sponsored by the DPP.

Trevor Parker, BRAC Development Manager, pointed out that retail theft in the last year cost over £4 billion, costing each household on average £120. He said that he disliked the term shop-lifting, call it what it is – retail theft.

Sgt. Alison Wylie from the PSNI then gave a very interesting address. She gave several

examples of how the thieves operate. Much of the detail came from information given by reformed thieves. She gave two simple examples of how to deter thieves

- make sure your shops are adequately staffed at peak times
- thieves do not like to be noticed a simple hello is often enough to put them off

Dean McAuley, the PSNI crime prevention officer pointed out that the law on the use of force changed in 2009, and gave everyone present an information sheet. He also gave information on the "right to search".

Trevor Parker also pointed out no individual has the right to enter any business premises – the trader has the right to refuse entry without giving a reason.

Trevor and Dean then covered a number of detection and deterrent methods that can be used to reduce retail loss.

Raymond Ruck, Chamber President closed the meeting and thanked everyone for attending. He wished everyone a busy and crime free Christmas trading period.

#### BALLYMENA RETAILERS AGAINST CRIME APPOINT NEW CHAIRPERSON.

### **BUSINESS BREAKFAST WITH ULSTER BANK**

Ulster Bank in association with Ballymena Borough Chamber of Commerce and Industry and Ballymena Borough Council held a very successful business breakfast in the Braid Auditorium in March.

A large number of Chamber members, business people, councillors and MLAs were present to hear Richard Ramsey, Chief Economist from Ulster Bank give a presentation on the current state of the Northern Ireland economy.

Mayor Maurice Mills welcomed everyone to the Braid saying he was looking forward to hearing Richard. He said that whilst Ballymena had undoubtedly been affected by the recession it continued to "punch well above its weight". He gave examples of the success of the Wright Group in recently securing a £55m order and the fact that Ballymena continued to be the best shopping town in Northern Ireland

The Mayor then introduced Terry Robb, the head of Ulster Bank's Business Centre in Ballymena. Terry thanked everyone for attending the breakfast and gave an outline of the services provided to businesses in Ballymena. He said "Banks are frequently criticised for not giving support to local business. However Ulster Bank is committed to supporting small business where we possibly can by providing a range of funding options. This year alone we have committed to lending £300m specifically to SMEs and we are keen to support good viable businesses"

Terry then introduced Richard Ramsey, Ulster Bank Chief Economist. Richard said that Mervyn King, Governor of the Bank of England, had christened the period 1998-2007 as the NICE decade – Non Inflationary Continuous Expansion. However that now seemed a long time ago. NI had gone into recession later than the rest of the UK, and whilst the UK economy was recovering, NI private sector output was showing no signs of growth. 38.000 jobs had been lost so far

and the economy has not yet felt the effect of the loss of public sector jobs. He summed up by saying that growth in 2011 and 2012 is predicted to be 1%, and unemployment is likely to stay high for a considerable time. The next few years will be tough for the NI economy. However it is not all doom and gloom. There is a great opportunity to radically change the NI economy for the better, but it must be taken. It is also thought that the public expenditure cuts will be difficult but are feasible. Events like the Olympics, the MTV awards which are scheduled to be held in Belfast and tourism will all help provide a boost to the economy.

## FUNDING AND FINANCE ADVICE TO HELP BALLYMENA BUSINESSES GROW

## Over 40 local Antrim businesses attended Beat the Clock: Focus on Finance at the Tullyglass House Hotel, Ballymena in March.

Business in the Community's Connections programme, sponsored by ESB Independent Energy, hosted the event, in partnership with DARD Rural Enterprise, Ballymena Borough Council, Ballymena Borough Chamber of Commerce and Industry, Ballymena Business Centre and Women on the Move.

The event was aimed at small business owners and managers interested in helping business survive the recession by improving their financial management and also where to seek funding and finance to grow the business. Guest speaker, Bill Ellison, shared his valuable experience of how to keep on top of credit control and getting the money in on time as an accountant and partner in BSx2, as well as from many years working in the private and not-for-profit sectors in finance and accounting.

Bill Ellison said: "As an entrepreneur myself, having set up and run three of my own companies in industrial heating, wholesale and distribution, and business coaching, I understand the challenges small business are facing in the current economic climate and I am delighted to be have the opportunity to pass on tips and advice to try and help other small businesses survive".

Heather Major, Business in the Community, highlights: "Our Connections programme aims to foster the sharing of knowledge and best practice with small businesses which can really make a difference to the sustainability of small businesses and to their future development.

Bill Ellison is also a Connections mentor and has been a key contributor from the outset to the programme's mission to help small businesses plan and achieve responsible growth."

After Bill's session on the programme, the participants at the event also heard presentations from five sources of business funding and finance. The sources included speakers from Enterprise NI Loan Fund, Halo Business Angel Network NI, E-Synergy, Michelin Business Development and the DARD Rural Development Programme.
